Jeff Fladen is currently serving as the Executive Director of NAMI Tennessee. He has brought order to office operations with the submittal of reports to funders on time with the organization of data. During the COVID-19 pandemic, the goal of the state office is to have a correct balance in a safe and compassionate manner while utilizing guidance from our system in support of the NAMI mission. The CODE (Correction Officer De-escalation Education) movie was developed and presented at the NAMI national convention. Through his untiring advocacy with law enforcement in Tennessee and throughout the U.S., CODE has been adopted by many law enforcement agencies. The Vision of Hope Gala was established as a fundraiser and promotes NAMI in the Nashville philanthropic community. Both the Vision of Hope Gala and NAMI TN State Convention have been significantly upgraded. Also, this is the second year for NAMI TN's participation in the NAMI walk. The first NAMI Tennessee Day at the Tennessee Capitol was held in 2019. This was a day for advocates to receive training on how to share their stories and speak with legislators. A sustainable budget was established and maintained with a reserve. The relationships with collaborative partners was increased. The State office under his leadership has increased visits, communications and training with affiliates. Since our state office receives most of its funding from the state, Jeff has been pursuing other income resources. Jeff can use his expertise to move the mission of NAMI forward.

This individual has helped advance the NAMI mission in my community by ensuring the Tennessee Affiliates are able to continue to provide NAMI signature classes in their communities. During CONVID-19, the NAMI at Home: Apart But Not Alone newsletter was created and distributed twice weekly to share information about mental health and coping tools. A Facebook live series is hosted every Monday interviewing persons involved in the mental health system from many different, diverse viewpoints and strategies.

This individual works well in coordination with other leaders to accomplish goals as evidenced by his participation on local boards. He spearheaded the development of the CODE movie. In the planning of the Vision of Hope Gala, he is able to obtain outstanding community leadership recognition due to his coordination with other leaders in the community. Also, Jeff received the 2018 Vicki Cottrell Leadership Award from the NAMI Executive Directors.
