Committee Work in the Coming Year

NAMI Office Move and Lease

Together, Mary Giliberti and Jimmy Stewart, reviewed the process by which two properties were identified as the potential new home of NAMI starting late 2019. The board discussed the financial immplications of both properties, as well as that of staying in the existing building. Barbara Ricci and Bob Spada offered unique perspectives as they were closely involved with both the financial considerations and in visiting the potential properties.

Upon motion by Bob Spada, seconded by Viceky Gonzalez, the board approved the motion to allow Mary Gilibertie to negotiate facvorable lease terms for the property ar 4301 Wilson Blvd. in Arlington.

Policy Update

Angela Kimball offered a high level oversiew of how the Advocacy and Public Policy team defines and executes its work on behalf of the alliance. She touched on major campaigns and efforts to influence legislation. The board discussed the effectiveness and impact of NAMI's advocacy efforts.
