Dear Chairwoman Capito, Ranking Member Baldwin, Chairman Aderholt, and Ranking Member DeLauro,

As the 119th Congress considers their Fiscal Year 2026 Budget, we, the 206 undersigned organizations who represent and care for America's children and their parents and caregivers, are writing to urge the inclusion of language on Family Resource Centers (FRCs) within the Social Services Block Grant (SSBG). These centers provide direct assistance to families through parenting support and education, screening and navigation of care services, mental health and family counseling, early learning and afterschool activities, family financial planning, and workforce supports. Specifically, we ask for report language within the FY 2026 Labor, Health, and Human Services (LHHS) Bill under the SSBG program that supports States who invest in the responsive and effective services and support provided by Family Resource Centers to strengthen families. This language was included on a bipartisan basis in the FY 2025 Senate LHHS Report, and we urge you to include it again.

Parents are struggling with some of the most complex and stressful circumstances in decades. With rising inflation, 1 in 4 parents struggle to pay for their family's food or housing.¹ 49% of K-12 teachers are worried about their students' chronic absenteeism.² Over 75% of parents are at least somewhat concerned about their children experiencing a mental health crisis or substance use problem.³ Yet, when families need support, it is unclear where to turn.

States have invested in Family Resource Centers as a proactive solution to fill this gap, and research shows that they've been successful. By strengthening families first, FRCs reduce unnecessary child welfare involvement by 63% in surrounding communities.⁴ For every dollar invested, FRCs provide a \$4.93 total return on investment and \$3.65 savings specific to the child welfare system.^{5,6} The programs offered by FRCs are provided through the center without regard for families' ability to pay and developed to reflect the specific needs and interests of the communities served. These programs have proven to lead to positive

outcomes across the family, including gains in economic self-sufficiency, educational success, health, social support, family functioning, resiliency, and child nurturing.⁷

However, FRCs currently lack a dedicated federal funding stream, instead patching together city, county, state, federal, and private dollars to serve millions of Americans each year. With this essential report language, Congress will encourage States and the Administration for Children and Families to prioritize Family Resource Centers in Social Services Block Grant spending. Therefore, we urge you to include the following language, which was previously included in the Senate’s Fiscal Year 2025 LHHS Report:

Family Resource Centers. —The Committee recognizes that Family Resource Centers provide direct assistance to families through parenting support and education, navigation of care and social services, mental health counseling, early learning and afterschool activities, family financial planning, and job training. The Committee notes that preliminary data shows promise in this area—with a 63 percent reduction in child abuse cases and a \$4.93 return for every tax dollar invested, according to current research. The Committee supports States that choose to use a portion of their SSBG funding to support services and programs at school and community-based Family Resource Centers to strengthen families through a localized, family-centered approach.

America’s parents and caregivers deserve the support needed to help their children thrive, and the effective Family Resource Center services funded through the Social Services Block Grant will ensure they are given this opportunity. We urge you to support this language request for SSBG.
